MODERN LAW INSIGHTS

Investment of Non-Qatari Capital - Foreign Investment



This article presents an overview of the Qatari legislative framework governing the investment of non-Qatari capital, highlighting the key provisions of Law No. (1) of 2019 on the Regulation of Non-Qatari Capital Investment in Economic Activity. These legislative updates were introduced to encourage greater foreign participation in the national economy while ensuring transparency and providing legal certainty for investors.

General Context and Importance of Foreign Investment

The article explains how foreign investment legislation aligns with Qatar National Vision 2030, emphasizing the importance of foreign investment in supporting economic growth, creating job opportunities, and diversifying income sources.

Law No. (1) of 2019 and the Expansion of Foreign Ownership

The law, which replaced Law No. (13) of 2000, permits non-Qatari investors to own up to 100% of a project's capital across all economic sectors – with certain exceptions – a significant shift from the previous ownership cap of 49%.

Conditions and Requirements for Foreign Investors Entering the Qatari Market

The article outlines the conditions that foreign investors must meet, such as good standing, legal registration, and activity compliance. It also explains the project-related requirements, procedures for requesting ownership exceeding 49%, and the grievance mechanism in case of application rejection.

Restricted Sectors and Regulations for Foreign Companies Contracting in Qatar

The article highlights sectors in which foreign investment is restricted, such as banking, insurance, and commercial agencies – subject to possible exemptions by a Cabinet decision. It also covers the requirement for foreign companies wishing to execute contracts in Qatar to establish a local branch and comply with registration and licensing regulations.

Incentives and Guarantees Granted to Non-Qatari Investors

The article outlines key incentives, including land allocation for projects, customs and tax exemptions, the ease of transferring profits and capital abroad, protection against expropriation except for public benefit with fair

compensation, and the freedom to choose dispute resolution methods (courts, arbitration, etc.).

Obligations, Penalties, and Exemptions

The article details investor obligations relating to environmental protection, public health, safety, and public order. It also presents the penalties imposed for violations, such as license withdrawal, deregistration, and fines reaching up to QAR 500,000. Furthermore, it outlines the entities exempted from the law, such as concession companies, companies in which the State holds a stake, and projects related to oil, gas, and petrochemicals.






